## On the establishment of Project Teams and Support Teams under the Police Reform Implementation Program

In order to coordinate the activities for the implementation of the provisions of the Police Development Strategy for the years 2016-2020, approved by the Government Decision no. 587 of 12 May 2016, in accordance with point 15 of the Regulation on the organization and functioning of the Ministry of Internal Affairs, approved by Government Decision no. 778 of 27.11.2009,

#### I ORDER:

- 1. The approval of the nominal membership of the Executive Secretariat, project teams and support teams within the Program Management Unit for the implementation of Police reform, as set out in the Annex.
- 2. Within 30 days of the entry into force of this order the Portfolio Coordinators, together with Project Managers within the Program Management Unit for the implementation of Police Reform, will:

The leaders of the subdivisions of the Central Aparatus, as well as of administrative authorities and institutions under the Ministry of Internal Affairs will ensure the participation at various activities of the subordinated project team staff, as well as of the appointed institutional experts and will offer all the necessary support for the fulfillment of specific tasks.
- 4. The control of the fulfillment of the present Order is under the responsibility of the Executive Secretariat of the Program Management Unit for the Police Reform Implementation Program.
- 5. The Order is brought to the attention of subdivisions of the Central Aparatus, administrative authorities and all interested institutions under the Ministry of Interior.
